1. Notices And Explanation.

This Lawful Notice is issued under the lawful jurisdiction of the Sovereign Peter-Andrew: Nolan© and the lawful Jurisdiction of the Mens Business Association which is Natural Law and Common Law.

This lawful notice is issued under the following maxims of law:

2. Lawful Notices

You are hereby Lawfully Noticed of the following:

1. You are hereby Lawfully Noticed that my calling is Peter-Andrew: Nolan©. I am also called Joschua-Brandon: Boehm©
2. You are hereby Lawfully Noticed that I am 49 years of age in good health and sound mind.
3. You are hereby Lawfully Noticed that you may find more details about me on www.peternolan.com.
4. You are hereby Lawfully Noticed that I am not under any coercion to write this Lawful Notice.
5. You are hereby Lawfully Noticed that I have been delegated authority to speak and write on behalf of the man calling himself Darrell of the Foote family.

The Notice authorizing me to speak on Darrells behalf in on the Australian CAF site under the Case Registry. We have created the case in the Case Registry to bring you to trial over this matter should you defy the Law. 6. You are hereby Lawfully Noticed you stand publicly accused of the kidnapping and unlawful incarceration of Darrell of the Foote Family.
7. You are hereby Lawfully Noticed that if you defy the Law that you will stand trial before a jury of your peers in the Mens Business Association Law Courts for this alleged crime. If you persist with this crime you will be given plenty of opportunity to defend yourself in a public, fair and just court of law.
8. You are hereby Lawfully Noticed that the Mens Business Association Law Courts are superior to any court of the Commonwealth of Australia because the Commonwealth of Australia is a Uniform Commercial Code Legal Entity registered on the US Securities and Exchange Commission. This means all such courts operate as Uniform Commercial Code Legal Entities because that is what the parent Legal Entity is. The Mens Business Association Law courts operate in Natural Law and Common Law. This makes them superior to any Legal Entity.
9. You are hereby Lawfully Noticed that you are well advised to release Darell of the Foote Family immediately on receipt of this Lawful Notice. At the latest you are to release him by close of business, meaning 5pm, Tuesday the 2nd of July 2013 as we reckon our calendars.
10. You are hereby Lawfully Noticed that whatever action you take, releasing Darrell or not, this action will be presented as evidence at your jury trial in the MBA Law Courts. The jury members will be asked to take into account whether you immediately acted when you were informed you were committing a crime on a Lawful Notice issued by me.

11. You are hereby Lawfully Noticed that the Nuremberg Trials established the precedent that “I was just following orders” is not sufficient defense for committing any crime.
 12. You are hereby Lawfully Noticed that you are personally and solely responsible for all your actions unless you can prove coercion.
 13. You are hereby Lawfully Noticed that I am in the sincere belief that you are in no way, shape or form, being coerced to unlawfully incarcerate Darrell. If you are being coerced please respond to the email address or fax number above and name those who are coercing you. Silence in response will be considered acceptance of the presumption you are not being coerced.
 14. You are hereby Lawfully Noticed that I have been authorized to perform an immediate Strawman Recapture process for Darrell in which I will formally and irrevocably rescind his consent to be governed in any way, shape or form without his expressed consent via his hand shake or signature in red ink made by his hand only.
 15. You are hereby Lawfully Noticed that once this set of documents has been put in place the fact at Law is that Darrell was never, at any time, subject to any legislation of the legal entity called The Commonwealth of Australia. This is a well established and formal process that is in line with the denials of jurisdiction Darrell has made in each interaction with the criminal cartel called the legal fraternity.
 16. You are hereby Lawfully Noticed that this rescinding of consent will be retrospective back to the time Darrell was born.
 17. You are hereby Lawfully Noticed that Darrell has consistently told the criminals in the criminal cartel called “The Australian Law Society” that he does not consent to the benefit of their services and does not accept the jurisdiction of the criminal cartels called “the legal fraternity” and “Police” in Australia.
 18. You are hereby Lawfully Noticed that all members of the federal parliament of legal entity called The Commonwealth of Australia have accepted that the Strawman Recapture process has standing in Natural Law, Common Law, and the Legislation of The Commonwealth of Australia.
 19. You are hereby Lawfully Noticed that among those who are fully aware of this process are the man calling himself Kevin Rudd and the man calling himself Robert McClelland who was the Attorney General of The Commonwealth of Australia at the time this precedent was established in 2009.
 20. You are hereby Lawfully Noticed that all members of the federal parliament of legal entity called The Commonwealth of Australia have been accused of associating themselves with crimes committed against me and have accepted their guilt on this matter as they were Lawfully Noticed of this in April 2011 and have not denied they know of these crimes and condone and support these crimes.
 21. You are hereby Lawfully Noticed that all members of the federal parliament of legal entity called The Commonwealth of Australia have had their cases entered into the MBA Law Services Case registry and will all be dealt with via the due process of law in the fullness of time. Those who refuse to admit their guilt and make remedy will stand trial.

22. You are hereby Lawfully Noticed that you are very well advised to immediately admit your guilt to the crime you have committed against Darrell, beg forgiveness, offer him a remedy that is to his satisfaction, and release him immediately upon receipt of this Lawful Notice.
 23. You are hereby Lawfully Noticed that the Mens Business Association supports the concept of Outlawry for those people found guilty of crimes who defy the Remedy Instruction issued by a jury of their peers. This means that the Jury reserves the right to withdraw the projection of the Common Law to any person who does not submit to the Common Law by voluntary consent. This means that should you defy the Mens Business Association Law Courts you will have the protection of the law withdrawn from you and you will live under Natural Law only and all that implies. 3. Summary
