EXPLANATORY NOTES

To the Public who may be reading this Affidavit of Accusation and not know what is happening.

The so called Courts of Law in Australia are a criminal cartel meant to make slaves of the Australian people. This has been well proven and the evidence is presented on the Crimes Against Fathers Australia web site for anyone who would like to determine the veracity of that statement for themselves.

In the face of the criminality of the courts and the government I, Peter-Andrew: Nolan©, and my colleagues, have made efforts over the last 5 years to introduce new and proper courts of law into Australia so as to re-introduce the rule of law in Australia.

My colleagues and I have received little support from the common Australian people who seem to prefer to remain ignorant of the situation in which they find themselves rather than to educate themselves on this matter. By such willful ignorance most Australians have waived any right to have any say in how those of us who have been risking our lives propose to re-introduce the rule of law onto the land known as Australia. If you wanted a say you were well advised to speak sooner.

In April 2011 new courts were proclaimed into existence with 29 signatures on the proclamation. The pre-requisite needed was 25. These courts were nominally called "The Peoples Courts of Australia". Principal makes oath that he is not a Psychopath or Sociopath and this public characterisation of being such constitutes the crime of slander.

Item 06

Principal makes oath that Chris Roubis ran a web site called www.chrisroubis.com". This web site was used to slander Principal. One example of this slander follows:

I and many others have had arguments with psychotic Peter Nolan about his delusions about abuse towards women but Peter Nolan resorts to becoming vindictive and defaming us on his websites.

Peter Nolan hijacks all Australan political facebook groups with his delusional views. Anyone that disagrees with Peter Nolan will become his enemy and be defamed on his websites with ridiculous stories about them.

So far Peter Nolan has been banned from 6 Australian political groups on facebook that I know of...and the number is growing. Peter Nolan is desperate for an army of followers to do his bidding here in Australia since he fled from Australia for domestic violence.

Peter Nolan uses many aliases in forums and groups on the internet to spread his vile beliefs towards women, and to gather men across the globe for his cause.

Peter Nolans followers are just a few thank god. No one is psychotic enough to follow a man like him.”

Item 07

Principal makes oath on the following points rebutting this slander on the public record and to the jury.

1. Principal is not psychotic.
2. Principal has never spread "women hatred". The fact that many people tell that lie does not make it true.
3. Principal has never defamed men as manginas on the basis that they do not approve of hitting women and children.
4. Principal does not resort to "becoming vindictive and defaming us on his websites". The truth can never be defamation or slander. It is, in all cases, lawful to speak the truth. It is indeed men like Chris Roubis and Chris Merrett who stoop to the crime of slander because they have no arguments to present to the public as to the matters I am presenting.
5. Principal has never "hijacked" an Australian political facebook. Indeed, if Principal had "hijacked" said facebook how could the argument Principal has been banned from 6 such facebook be true?
6. It is not the case that anyone who disagrees with Principal becomes my enemy and is defamed on my websites with ridiculous stories about them.
7. Principal has not been banned from 6 Australian political groups on facebook. If Chris Roubis would like to make this case then he can NAME THEM. I was banned from 2 Australian political facebook. The Australian Sovereignty Party and the Australian Patriots Party. I was banned on the basis that I proposed these parties would be well advised to form new courts of law and hold women accountable for their crimes in an equal before the law basis.

The very fact so called "Political Parties" ban someone for proposing women are held equal before the law clearly demonstrates these "Political Parties" do not have the agenda of "equal before the law" no matter how much they protest that they do.

Principal notes that both "Political Parties" have, at no time, suggested that women be held accountable for their crimes, have, at no time, suggested the creation on new courts of law, and have been totally ineffective in their supposed "efforts" in the nearly two years since I was banned from them.

8. Principal is not desperate for an army of followers. I have, on many occasions, told men I do not want ANY "followers" because I recommend men lead themselves and do not "follow" anyone.
9. Principal did not flee Australia for any accusations, false or otherwise, with respect to domestic violence.
10. Principal does not use many aliases in forums and groups on the internet. I did use Globalman and one other for some time until the criminals Michael Toal linked me to the Globalman persona in October 2010. Since then I have not used any aliases at all to present what I have to say.
11. There are now some 400 men registered to CAF sites around the world and that number is slowly growing. Men are starting to realise just how badly they are criminally victimised.

Chris Roubis is welcome to prove all the claims he made on an Affidavit of Reply.

Item 08

Principal makes oath that based on all of the above evidence plus a great deal more evidence Principal formerly and irrevocably accuses Chris Roubis of three crimes.

1. At least 10 counts of copyright violation for the use of my name, calling and image in many public places over an extended period of time while being fully aware that my name, calling and image are copyrighted materials.
2. At least 2 counts of slander. Namely the crime of telling known and deliberate lies about a man with the intention of causing injury, harm and loss.

Chris Roubis can decide for himself if he will deny this item for item on an affidavit under oath and penalty of perjury and full commercial liability. Should he not deny these items then he has accepted it and the jury must find that he has accepted that he set out to commit these crimes with full knowledge and forethought with malice of intent.

Done this.....Day of the Fourth Month of the Year of Our Lord Two Thousand and Thirteen Anno Domini, (8th April AD2013) near Karlsruhe, Germany.

Please note that this Affidavit has not been countersigned by people living in Germany.

In Lieu of counter signing the Mens Business Association stamp has been applied to each page so as to ensure the veracity and authenticity of each page. Further, because Principal will read this affidavit into the public record and publish said record via You Tube the public and the jury can be assured that the man making the allegations is Peter-Andrew: Nolan© and that these allegations are in no way fraudulent.

Proposed Remedy And Notice of Intent

Chris Roubis has deliberately and with malice of forethought and intent committed the crime of slander against Principal.

Principal had never caused Chris Roubis any injury, harm or loss. Indeed, prior to this criminal attack by Chris Roubis Principal had no knowledge of Chris Roubis.

The crimes of which Chris Roubis stands accused are a calculated, vicious, pre-meditated, continual assault on my good name for no good reason at all.

Given this is the situation I would petition the jury that reviews this case to consider the remedy you would wish were someone to perform the same calculated, vicious, pre-meditated, continual assault on YOUR good name for no good reason at all.

Principal proposes as the Proposed Remedy the sum of **AUD20,000** as damages to peacefully remedy the crimes Chris Roubis has committed. The jury might decide to vary that remedy amount. This remains the amount that Chris Roubis must pay Principal to avoid the proposed jury trial.

The Proposed Remedy payment is hereby made due on 2013-04-30 and can be made to peter.nolan.paypal@peternolan.com or can be made to an Australian Bank Account to be provided privately to Chris Roubis.

Should Chris Roubis not make the remedy payment by 2013-04-30 then the due process of law will be followed as outlined below as Principals Notice of Intent.

Should Chris Roubis not respond to this affidavit a Default Judgment will be issued against Chris Roubis and he will have admitted his guilt by silence. In this case an MBA Court of Law will be convened by the Mens Business Association to review the evidence, determine it's veracity, consider the Proposed Remedy Payment and issue Instructions as a properly convened court of law. The jury will decide what to do.

Should Chris Roubis respond to this affidavit then he is required, by law, to respond item for item. Any item he does not respond to will be considered conceded. Any item he rebuts he must rebut under the penalty of perjury and full commercial liability.

Principal notes that in Australia the penalty for perjury seems to be 10 years when performed before the International Criminal Court. And that seems fair enough to me. We shall adopt the same standard for the MBA Law Courts in this case since the precedent has been set.

268.102 Perjury

(1) A person commits the offence of perjury if:

(a) the person makes a sworn statement in or for the purposes of a proceeding before the International Criminal Court; and

(b) the statement is false.

Penalty: Imprisonment for 10 years.

Chris Roubis is well advised not to commit the crime of perjury.

Should Chris Roubis reply with an Affidavit of Reply and deny the crimes of which he stands accused then the matter will go to trial under the jurisdiction of the MBA Law Services. The MBA Law Services will convene a Common Law Court operating under the jurisdictions of Natural Law and the Common Law of the land known as Australia.

Chris Roubis will be offered the opportunity to avail of or deny the protection of the Common Law of the land known as Australia. To avail of the protection of the Common Law of the land known as Australia he will accept the invitation to present his rebutting information to the jury via way of Affidavit and video evidence. This affidavit and video evidence will be viewed by a jury of 12 honest men of honour and integrity who live on the land known as Australia.

The Secretary of the MBA Law Court will be appointed to proceed with the court process as and when Chris Roubis makes his intentions clear. The Secretary of the MBA Law Courts will not reside on the land known as Australia in this case as ASIO has attempted to harass and intimidate the man who agreed to be the Secretary for this trial process.

The Secretary will be someone known to me and is an honest man of honour and integrity. His identity will be protected. In order to protect his identity all paperwork will be signed by the Secretary and then that signature will be hidden from public view. The original documents will be retained in a safe place out of the reach of any police enforcement officers of any land.

If the Australian Public wanted a more transparent process then the men of the Australian Public were well advised, by me, to come forward in numbers so that harassment and intimidation by your servants in ASIO would not have proven effective against an elderly man who is, in fact, retired. It is a sad comment on Australian men that you did not extend your support and protection to a retired gentleman who had the bravery to stand up for all Australians.

Now. Chris Roubis has until 2013-04-30 to make one of the following actions.

1. Admit his crimes and pay the AUD20,000 remedy payment.
2. Refuse to reply to this Affidavit of Accusation and thereby accept a default judgement of guilty as accused and have the jury review the evidence to determine its veracity and then to issue instructions as the jury sees fit with no defense from Chris Roubis offered. The Jury Instructions will then be processed according to the due process of law.
3. Reply to this Affidavit of Accusation contesting the accusations and contesting the items presented under penalty of perjury and full commercial liability, noting that the penalty for perjury appears to be 10 years in jail in Australia. The length of incarceration or the withdrawal of protection of the law to be a matter for the jury to decide.
