I, Peter-Andrew: Nolan© (aka Joschua-Brandon: Boehm©) am issuing this Lawful Notice under the jurisdiction of my own sovereignty as the grantor of original jurisdiction, the jurisdiction of Natural Law being the law of the creator to which we are all subject, and the jurisdiction of common law, being the law of agreement of the people who live on a particular area of land.

This Lawful Notice is issued under the following maxims of law:
