Greetings and Salutations to my Dear Sisters.

It seems that I am in need to address you all again. So some sections of this letter will be presented in blue italics. The blue italics is the background explanation for the young men.

They refuse to do this. This makes them ALL LIARS AND HYPOCRITES. That I can get a perfect result of 250 out of 250 women from a group that is WEALTHY AND WELL EDUCATED I can therefore claim that the VAST MAJORITY of western women are LIARS AND HYPOCRITES and will not hold a woman accountable for her crimes when she commits these against a man. These women come from MANY countries across MANY cultures. But they ALL agree that a criminal woman is to be protected. How about that for a great sample set!

In short? I have PROVEN that women wish impunity for crimes committed by women against men in the west in the VAST MAJORITY. By the way? MOST MEN ALSO CONDONE SUCH CRIMES. I will also note to the lads that the criminal woman, Irene Toal, the woman who participated in the abuse of my elderly and ill mother, was later allowed to tend to my mother in her demented state and illness.

I was so thoroughly disgusted in my father that he allowed this that I told him that if I did not have a letter in his own hand denouncing Jennifer, Bill and Irene as the criminals they are prior to the event of my mothers death then I would not be coming to the funeral. I would NOT dishonour my mother by burying her with those who abused her in attendance.

Marriage today is nothing but slavery for the man enforced by the criminal state at threat of incarceration and the women know this and CONDONE IT. That the members of the governments know they are criminals has been proven to be true and the paperwork is below.

So my advice to young men is to give western women the husbands they deserve. NONE. They want to commit crimes against you with impunity. This is not refutable. When women have proven they can be "equal before the law"? Then it might be time to reconsider.

There. The introduction to the lads is over.

As I have said openly before. I have no problem with Jennifer being a prostitute if that is what she wanted to be. When I traveled around ASIA a LOT of prostitutes tried to sell me their services. They seemed like likeable enough women and they never caused me any problems even when I refused to buy what they were selling. Most men have no problem at all with prostitutes. Indeed? I take the position that what two consenting adults do in the privacy of their home or hotel is no one else's business. Women are totally hypocritical on the issue of prostitution because when it comes to abortion they claim "my body my choice" but when it comes to prostitution they claim "her body, and I should be able to tell her what to do with it". Women are either free to engage in consensual acts or not. My position is that they are able to be responsible for their own actions and no one can tell any adult woman what she may or may not do as long as all parties agree.

It is usually women who have problems with women who are prostitutes being around their husbands.

Lads. Jennifer did not need the money as she had PLENTY of money available to her as equity in the house. She just refused to release the equity in the house. We had a mortgage of \$A225,000 on a house that was eventually sold for a very low price at \$A550,000.

You REFUSED to assist him.

ALL OF YOU.

I also mean the women who pretended to be my friends and not just the women of the International Womens Club of Dublin.

If any of you had any honour you would be ashamed of yourselves and your behaviour.

What do your husbands think of you openly supporting a criminal woman against her honest husband?

What do your fathers think, your sons, your brothers?

Have you been open and honest with the MEN in your lives and told them that you openly supported a criminal woman over an honest man just because she is a woman?

Any woman who does not have one of these filled in and registered with us will be assumed to be "equal before the law" to men by us men. That means we can put you on trial in OUR courts as we please.
