1. Notices And Explanation.

This Lawful Notice is issued under the lawful jurisdiction of the Sovereign Peter-Andrew: Nolan©.

Dear All,

A Lawful Notice is a Lawful document that formally and irrevocably informs a human being of some fact or other. From the date of the Lawful Notice being received by the human being that human being may not claim 'ignorance' as a defense in a court of law for those items listed in the Lawful Notice.

It does not matter if you believe what is in the Lawful Notice or not. If what is in the Lawful Notice is true you are deemed to have been in possession of this information from your date of reading the Lawful Notice.

Dis-belief of what is in a Lawful Notice is not a Lawful excuse for committing crimes.

This Lawful Notice is written in the English Language and NOT Legalese.

In this Lawful Notice, when I wish to address an individual I will use @Name to address that individual. Where no @Name is used you may assume @All.

2. Background Information for Third Parties

If you are a Third Party to this Lawful Notice or you are one of those Lawfully Noticed but have not received a Lawful Notice like this before then you might want to read through this brief background.

The bottom line is that the members of Parliament in Ireland now hold the lawful status of criminals. When it is possible they will be put on trial for their crimes and tried before a jury of 12 honest men of honour and integrity who live on the land commonly called Ireland.

Those 12 men will judge each of the current members of the Parliament and decide their Innocence or Guilt based on the evidence that will be presented by myself as the accuser. Should the Jury find each politician guilty, which is a foregone conclusion but due process of law must be followed, the Jury will issue the Remedy Instruction that reflects the unanimous decision of the Jury as to what Remedy is fair and just for the crime of which the politician has been found guilty.

We have come to this position via what I can only call a daring effort on the part of myself. I came to realize that the man calling himself "Judge Griffin" of the Family Court in Ireland was a criminal in late 2007. He was so blatantly a criminal that it was clear that he felt he could be a criminal with complete impunity. I have news for "Judge Griffin" and it is all bad. The people on the land are the ultimate authority and are the judges of criminality and remedy. NOT the politicians. The politicians are PUBLIC SERVANTS and therefore they are obliged to do what the public TELLS THEM TO DO.

Irish Politicians have sold their souls to the British Monarchy and have been doing the bidding of the British Monarchy in establishing a police state in Ireland. I would have thought that with the struggle for freedom so recent in Irish History after so many hundreds of years of ruthless oppression by the British Monarchy that Irish Men and women would not be willing to sell their souls to the British Monarchy and do the bidding of the British Monarchy for fear of the inevitable reprisals of their fellow Irish Men. I was mistaken.

Apparently Irish men and women in the Parliament believe they will be somehow protected. I fail to understand how they could come to such a conclusion. I fail to see how they could believe that their activities would not be exposed and that some Irish men might be very, very upset about what they have been doing. The most notable example of which is Gerry Adams. Gerry Adams has been mouthing off about freedom and liberty for as long as I can remember. But when it is pointed out to him that a judge committed criminal acts and is an agent of the British via his oath to the LAW SOCIETY Gerry Adams stays silent.

How long can it be before some of the men who are honest men who were in the IRA figure out that Gerry Adams is a willing agent of the British? How long will it be before Irish Men start to join the dots and realize that all members of the LAW SOCIETY are bound by oath to serve their masters, the British Monarchy? Surely it can not be too long now. That every single politician in BOTH houses stayed silent when presented with the PROOF that "Judge Griffin" committed criminal acts shows you who they all work for. They protect the LAW SOCIETY and that is based out of LONDON.

When this silence on the crimes of Judge Griffin was followed up with EVERY single member staying silent when Alan Shatter committed a further criminal act of unlawful discrimination against me shows every Irish Man reading this document that ALL your members of your parliament are quite prepared to openly support and condone criminal acts by judges, other politicians, lawyers and police.

In essence, this makes Ireland a police state. The police have been Lawfully Noticed of this situation and failed to live up to their OATHS of protecting the people of Ireland.

This whole situation began when my former wife, Jennifer, committed perjury in her affidavits that were presented to "Judge Griffin". She signed those Affidavits on 8th of November 2007. The reader might well wonder why it is that it is August 2012 and this crime of perjury has not been remedied. It is because the legal fraternity are criminals. That is why it has not been remedied.

So in June 2008, having survived a month being suicidal in April 2008, I developed a bold plan to re-introduce the rule of law into Ireland and Australia. To do this I would have to be willing to stand up for my rights against the criminals in government of two nations. Almost immediately I started executing on this plan the criminals sent one of their stooges to meet me and offer me a job. "We need people like you to bring in the New World Order" he said. "With your skills you can help us control the world" he said.

I was VERY shocked to be tracked down and offered a job but also very pleased. It meant that I had obviously hit on the correct plan and correct path of action. If not they would have ignored me. Thereafter I was subject to mild forms of harassment while the criminals in the courts proceeded to steal my house from me and give it to my former wife.

You see. The key approach of the criminals in the government to oppress everyone is to make women the beneficiaries of their crimes. Then any man who stands his ground is slandered as a "woman hater" and other men and women are incited to hate on the man who is actually the victim of the crimes.

This is why women can commit perjury with impunity in Ireland. This is why women can make false allegations all day long and no one will prosecute her. Perjury is not only condoned it is actively solicited and supported by the legal fraternity and women are only pleased to commit the crime of perjury based on the promise they will not be held accountable for their words.

Virtually ALL women in Ireland know this to be true and openly support and condone the practice of perjury by other women even if they are not committing this crime themselves. Certainly every single woman AND MAN in the parliament are well aware women commit perjury to make false allegations in large numbers and ALL members of the parliament suppressed the news of this fact.

Further. In the family courts the women are rewarded for their perjury by being given the house and kids and all the assets as well as orders against the man for a great deal of money. The orders of "Judge Griffin" were so laughable as to be ridiculous.

"Judge Griffin" ordered 100% of the family income to be given to Jennifer. He further ordered that faxes sent to a third party fax machine in a third party jurisdiction constituted "good service" and on basis of that LAUGHABLE ruling he froze my bank accounts and committed the crime of extortion by threatening me with incarceration if I did not pay his extortion money to Jennifer Toal.

The whole thing was a JOKE at law and I knew it. The issue was to gather up sufficient evidence to PROVE these crimes and then come back at "Judge Griffin" one day. But that was not the end of the plan. What I wanted was to draw as many criminals as possible out of their hiding holes so that they committed criminal acts against me. Each criminal who committed a criminal act would then be able to be put on trial when we establish our new courts in Ireland.

So. That was the plan. Get myself criminally victimized as much as possible and gather up the evidence for later prosecutions. A bold and brave plan if I must say so myself. There was a time when I thought I might be killed so I had to guard against any order to kill me as best I could.

The Truth Be Told is intended for young men 16 to 30 in the English speaking world. It is to explain to them just who exactly they have been betrayed by. They are being betrayed by the vast majority of older men, politicians, police, legal fraternity and their women, including their peers.

Indeed the entire system of “social order” is based on the betrayal of young men to enslave them to older men and women. This is the news that is being released to the young men. They are starting to “get it” in increasing numbers. They are noticing that they are only “socially acceptable” if they are willing slaves to politicians and women. I am using my life’s example to educate the young men. I was a man who was eminently “socially acceptable” while I was a willing slave. In Ireland I was on the “embassy party circuit”. My clients were big names. But somehow I became “not socially acceptable” for being the victim of criminal acts by a woman and the legal system. I thought it was a crime to discriminate against people based on their marital status. Nope.

In the English speaking world a man who is divorced and standing up for his rights is hated on much more than a black jew would be hated on in 1930s Germany. Indeed. Since I was so hated on in the west I relocated to Germany and spend most of my time there. Unlike Irish people, Germans do not hate on a man just because his wife is a criminal and he is demanding justice. In Germany women are “good women” and they demand that women who commit crimes are dealt with in very similar fashion to men. German women demand equality before the law. Irish women demand impunity for women for criminal acts.

Every single woman in both houses of the parliament has demanded that Jennifer Toal have impunity for her criminal acts merely because she is a woman. They did this by staying silent. This is the height of hypocrisy and it is being exposed by me and many other men.

The Truth Be Told contains all the links and all the details required by any person who would like to fact check my statements. I will not put all the links in the Lawful Notices since they will just clog up the Lawful Notices. Where I claim something is true in the Lawful Notices the evidence is presented in The Truth Be Told.

With all that said? The following section contains my Lawful Notices to the addressed parties.

3. Lawful Notices

You are ALL hereby Lawfully Noticed of the following except were restricted to those who are specifically named.

1. **@Members of the houses of Oireachtas.** You are hereby lawfully noticed:
 - a. That on the date of November 8th 2007 Jennifer Marguerite Toal signed an Affidavit containing perjury.
 - b. That this is a criminal act. It was the crime of **PERJURY**. “Thou shalt not bear false witness against thy neighbour” is not something that I made up. You can find this defined as a crime in your **CHRISTIAN BIBLES**. That you have not required Jennifer to make remedy for this crime in **FIVE YEARS** means you are **DEFYING YOUR OWN GOD AND HIS COMMANDMENTS**.
 - c. That this failure to offer the protection of the law to one of your fellow Christians, me, makes anyone reading this who claims to be a Christian a HYPOCRITE because you claim to be a Christian but failed to defend one of your own against a fallen women who committed a crime against one of your own. You failed to offer the protection of the law to two children whose mother broke her vow to raise those children in the faith she married in. You failed to protect the immortal souls of two children. Disgusting. There is no other word for it. And all for what? So the “holy mother of a woman” did not have to face the consequences of her actions?
 - d. That all subsequent acts against me stemmed from that criminal act.
 - e. That the said criminal act was committed on the land commonly known as Ireland.
 - f. That I have spent some nearly five years calling on the people of Ireland to provide me with a community supported path to justice so that I do not have to take the law into my own hands to deal with this and subsequent criminal acts.
 - g. That I have been hated on, demonized, vilified, slandered and treated in the most despicable ways by many people living on the land of Ireland for wishing nothing more than Jennifer Toal be held “equal before the law” and be held accountable for her criminal acts.
 - h. That the people of Ireland are some of the most hate filled, angry, sexist, discriminatory, bigoted people I have ever encountered in my life. And I have spent 15 months in Saudi Arabia.

No Saudi EVER treated me with the **HATRED AND CONTEMPT** that Irish people have treated me with. Irish people compare very poorly to Saudi people. Indeed Christian people compare very poorly to Muslim people. It is easy to see why Muslim people believe Islam is far superior to Christianity. It is because it is. Islam does not allow for such mistreatment of men and children in favour of a criminal woman.

- i. That the people of Ireland commonly surpass the level of hatred espoused by the National Socialists in Germany against Jews, Gypsies and Blacks. It is no exaggeration to say that I could not be treated as badly in 1930s Germany as a Black Communist Jew than I have commonly been treated by the people who live on the land of Ireland.

2. **@Members of the houses of Oireachtas.** You are hereby lawfully noticed:
- a. That the behaviour of Irish people towards a descendant of Irish people (I am a Nolan-Pell) has been a disgrace from one end to the other. I have been treated worse in Ireland than I would EVER be treated in Saudi Arabia or would have been treated in National Socialist Germany as a Black Communist JEW!. That the behaviour of Irish people can be unfavorably compared to two regimes that are commonly cited as being “oppressive” is a very sad reflection on the Irish people and those of you who claim to be their re-presentatives.

People born in Australia have made Irish people welcome for 150 years. But when an Australian of clearly and irrefutable Irish descent comes back in the other direction he is hated on, demonized, vilified and discriminated against merely because his wife is a criminal and he demands a path to justice.

If the members of the houses of Oireachtas had any honour you would feel shame for your actions and the actions of the people you claim to re-present.

HOW DARE YOU TREAT ME IN SUCH A WAY AS YOU HAVE!

- b. That despite Jennifer Marguerite Toal being a KNOWN criminal and child abuser she was granted citizenship of Ireland in 2009, along with her children, while I was denied based on lies. These lies have been sent to you in a prior Letter which you can find on this link.

This was a clear case of criminal discrimination which has not been denied by Alan Shatter. Nor has Alan Shatter denied that his unilateral decision to deny my citizenship application is a clear case of criminal discrimination.

- c. That on the date of 2012-02-24 I issued a Lawful Notice to all members on the topic of the discrimination committed against me by Alan Shatter in unilaterally denying my citizenship application in Ireland.
- d. That I have not had one response from any member of the houses of Oireachtas with respect to such blatant criminal discrimination. This is a disgrace. You were ALL Lawfully Noticed of a clear criminal act and NOT ONE of you wished to discuss it.

NONE of you can claim to re-present anyone.

NONE of you can claim to be honest or interested in fairness or justice.

You have waived ANY right to claim your positions or your salaries.

You have waived ANY claim to respect of any thinking man.

3. **@Members of the houses of Oireachtas.** You are hereby lawfully noticed:
- a. That in November and December of 2007 a man calling himself “Judge Griffin” committed a series of criminal acts against me. He did this in the apparent certain knowledge that he would not be held accountable for his criminal acts. These criminal acts included such total nonsense as:
 - i. Claiming that sending documents by fax to a third party legal entity in a third party jurisdiction constituted “good service” of the documents.
 - ii. Claiming that based on said **LUDICROUS** ruling that he had the right to shut down my personal and business bank accounts thereby impoverishing me and reducing me to begging from family and friends to access money to live on.
 - iii. Openly supporting the perjury of Jennifer Toal and taking perjurious testimony as his basis for committing further crimes against me rather than simply contacting me directly. Since my web site is www.peternolan.com there can be no excuse why a man who is simply providing contracted services (and is NOT a real judge) did not contact me before acting against my interests.
 - iv. Issuing an order for 100% of the family income to be paid to Jennifer. What, pray tell, was I supposed to live on?
 - v. He subsequently threatened me with incarceration should I not pay this “money” which is, in and of itself, the crime of extortion. I relayed to the judge via the criminal Piarais Neary of P. W. Tracy Solicitors in Dublin that should he do so I would make my first order of business on release to kill him for his unlawful incarceration of me. “Judge Griffin” finally started showing some sense and did not issue the threatened order for unlawful incarceration.
 - b. That given that “Judge Griffin” committed these crimes over his signature and his stamp makes it clear he was WELL AWARE that no member of the “govement” or “law enforcement” would hold him accountable for his criminal acts.
 - c. That given the above “Judge Griffin” provides irrefutable evidence that he knew full well that the government of Ireland was a criminal cartel in November 2007. This means that ALL ACTIONS of subsequent government public servants are “odious” as they were not being taking in the best interests of the people they claim to re-present. This means that the EU85 Billion bail out is an “odious debt” and does not need to be repaid in taxes by the Irish people. Those who were in government at the time can pay it. They agreed to it. Not the Irish people.
 - d. That, lastly, the actions of “Judge Griffin” were the spark that had me pursue the situation further. “Judge Griffin” was clearly risking his life by criminally abusing me. It made me wonder “Who is he more afraid of than me?” That would be your criminal masters.

Let me assure all members who read this. I will have my path to Justice with “Judge Griffin” or “Judge Griffin” is a dead man walking. He can choose which way he wants to settle his crimes against me. I believe in freedom of choice. I am sure Alan Shatter will know “Judge Griffin”. He might like to pass along my message. The steeling price is EUR1.5M that being 10 times the amount he tried to extort from me.

4. **@Members of the houses of Oireachtas.** You are hereby lawfully noticed:
- a. That in October 2009 I called on the 300 or so women on the TNS Freeman site to form an all womens jury in an all womens court to put Jennifer Toal on trial for her crime of perjury on the land known as Ireland. Only three of 300 agreed. One reported she was verbally attacked by other women for agreeing to do this.
 - b. That in October 2010 I called on the 2,000 or so men on the TNS Freeman site to form an all mens jury in an all mens court to put “Judge Griffin” on trial for his criminal acts against me. Only 4 men could be found who would do this. This was not enough.
 - c. That on July 21 2012 I called on the 3,000 or so members of the TNS Freeman site to form an all mens jury in an all mens court to put Jennifer Toal on trial. None responded. Video link here: <http://youtu.be/AYQg97bohzM>
 - d. That on August 14th in 2012 I responded to the lack of response. Video link here: <http://youtu.be/CwCZaT9cbXs>
 - e. That on October 15th 2010 I issued a Lawful Notice to both Brian Cowan and Mary McAleese to describe in detail the criminal acts of “Judge Griffin”. The office staff of both responded that they had received the more than 60 pages of evidence that was presented to them. No answer has been forthcoming.
 - f. That in 2012 I have sent numerous notices and emails to the **ENTIRE MEMBERSHIP** of the Irish Parliament and, to date, there has been a woefully inadequate response.

The closest that could be classified as a “response” is an email allegedly from the office of Alan Shatter claiming that the members of the parliament have **NO ROLE TO PLAY** in bringing a criminal judge to justice.

Since Alan Shatter has made it clear that the **MINISTER FOR JUSTICE** does not include in his responsibilities the obligation to bring to justice criminal judges **I CLAIM THE RIGHT** to perform that role myself.

If anyone reading this Lawful Notice would like to dispute this claim of right you are most welcome to do so based upon **PROOF OF CLAIM** that someone else is already providing that service in an open, transparent, just and fair way.

- g. That at this following internet address you will find the Directive 2004/38/EC of the European Parliament and of the council as of 29 April 2004 on the right of citizens of the Union and their family members to move and reside freely within the territory of the Member states.

Feel free to go ahead and read it ladies and gentlemen. You are signed up for this so you should make sure you know what you signed up for.

5. **@Members of the houses of Oireachtas.** You are hereby lawfully noticed:
- a. That on the third page of this document, item number 5, it says, and let me quote so that none of you are in any doubt as to what you signed up for.

*“The right of all Union citizens to move and reside freely within the territory of the Member States should, if it is to be exercised under objective conditions of freedom and dignity, **BE ALSO GRANTED TO THEIR FAMILY MEMBERS, IRRESPECTIVE OF NATIONALITY.** For the purposes of this Directive, the definition of “family member” should also include the registered partner if the legislation of the host Member State treats registered partnership as equivalent to marriage.”*

Given that I was **CRIMINALLY VICTIMISED** by “Judge Griffin” on the basis that I was the **FATHER** of two people who are **NOW IRISH CITIZENS** this statement makes it very, very clear that you were **OBLIGED** to renew my residence visa while the issue of citizenship was sorted out.

- b. That, **ACCORDING TO YOUR OWN RULES**, and despite the criminal act of Alan Shatter in denying my citizenship application without cause, the Irish Guvment is **OBLIGED** by this directive “under objective conditions of freedom and dignity” to agree to my residency in Ireland.

Let me repeat that for you.

OBLIGED “UNDER OBJECTIVE CONDITIONS OF FREEDOM AND DIGNITY”

Now? How much “freedom and dignity” have the members of these two houses been so willing to show me? Not much. What a disgrace you are to the Irish people.

@Alan Shatter. I will be expecting my letter from you personally directing the NIS to issue me with another five year residency visa by September 1st 2012.

Continued failure by Alan to issue me a letter I can take to NIS to get my residency visa put into my passports will continue to be charged at EUR800 per day for ALL members of parliament because you are ALL obliged to make sure you follow these directives.

- c. That I held this little morsel back for a few months AFTER all members refused to lift **ONE FINGER** to assist me in my residency situation in Ireland so as to be able to put you ALL on the hook for **DAMAGES** for refusing to **DO WHAT YOU ARE OBLIGED TO DO.**

If any of you had actually bothered to go and have a look at this **DIRECTIVE** you would have seen you were **OBLIGED** to provide my residency permit when it was expiring in April 2012 and you would have SEEN TO IT that you did not commit the crime of obstruction of justice by denying me something that you were **OBLIGED** to grant by the very directives you are **OBLIGED** to follow on the basis of **FREEDOM AND DIGNITY.**

Did I tell you people how much trouble you are in?

Do you people even realize how badly you have been exposed as criminals who will not even follow your own rules?

6. **@Members of the houses of Oireachtas.** You are hereby lawfully noticed:
- a. That given all of the above I claim that I have made every effort to remedy the crimes against me peacefully and in writing in the most public of possible ways.
 - b. That all such public efforts have been spurned despite the fact that I have received MANY assurances that Enda Kenny has received all correspondence from me and had taken my matter into consideration. Enda has failed to provide any substantive response.
 - c. That given that **TENS OF THOUSANDS** of other Irish Men have complained bitterly and openly to the members of the parliament over the issues of criminal victimisation by family court judges and have **ALL** had the same **DEAF EAR** turned to them.
 - d. That the members of the Parliament have attacked and injured the wives and the children of Irish Men with your campaign of hatred, demonisation, vilification, and criminal victimization of the men of Ireland via the family courts.
 - e. That I claim that the members of the Irish Parliament are following orders from the United Nations to destroy the nuclear family in Ireland in preparation for introducing a hard police state to succeed the already implemented soft police state.
 - f. That I claim that the family law legislation being enacted in Ireland and the criminal prosecution of fathers in Ireland are mandated by the United Nations and are not reflective of the desires or aspirations of the Irish People and is in direct violation of the Irish Constitution which holds the nuclear family **INCINCIBLE** to any intrusion by **ANY** agent of the Irish Guvment.
 - g. That I claim that the members of the Irish Parliament are doing the bidding of the British Monarchy in following the orders from the UN to destroy the Nuclear Family as the British Monarchy holds great sway in the orders emanating out of the United Nations and holds great sway with such families as the Rothchilds, Rockefellers, Warbergs, Habsburgs et al.
 - h. That I claim the members of these two houses are prosecuting a **WAR ON FATHERS** and a **WAR ON THE NUCLEAR FAMILY** at the behest of the British Monarchy and the United Nations.
 - i. That I claim that this **WAR ON FATHERS** has been in progress some decades all across the western world and has been well known about inside political and legal circles for many years.
 - j. That I claim this **WAR ON FATHERS** is a part of the United Nations "Population Control" agenda which also includes a war on unborn babies of whom some **TWO BILLION** have been murdered in the name of "womens rights" and "right to choose" for women to kill a MANS BABY with an abortion with no rights of the father secured.
 - k. That I claim there can be no reasonable hope or expectation that "The Peoples Court of Ireland" can be established to re-introduce the rule of law and provide the protection of law to fathers in Ireland in the foreseeable future. That all efforts to date to establish such courts have been met with rejection from the members of Parliament, members of the Gardaí, and the people who live on the land of Ireland.

7. **@Members of the houses of Oireachtas.** You are hereby lawfully noticed:
- a. That given all of the above I claim that a **STATE OF WAR** exists between fathers and the following groups in Ireland for the following reasons.

- i. **Members of the Parliament.**

Reason: Passing, sustaining and supporting legislation that is criminal in nature to legitimize the criminal victimization of fathers under the pretence that it is the woman who is being “protected and provided for”.

It is not lawful to commit crimes against a father on the grounds that the beneficiary of the crime is “women and children”. We have seen that with the criminal victimization of fathers the women and children end up being poorer and more oppressed without the father and husband to defend them against an increasingly virulent bunch of criminals in the parliament.

- ii. **Members of the LAW SOCIETY.**

Reason: All members of the LAW SOCIETY are aware of the Magna Carta and aware of the limitations it places on any government in the English speaking world in actions being taken against the people who live on the land.

ALL members of the **IRISH LAW SOCIETY** are aware that the Constitution of Ireland holds the nuclear family **INVINCIBLE** against any action by ANY agent of the Irish Government.

ALL members of the **IRISH LAW SOCIETY** are well aware that the Irish Government and the Judges are violating the Irish Constitution, the Magna Carta, the very commandments of the bible itself. “Do unto others as you would have them do unto you”.

This includes ALL judges, ALL magistrates, ALL Lawyers, ALL Registrars and other members of the Law Society and their direct employees.

- iii. **Members of the Gardai.**

Reason. On March 22nd 2011 I issued a Lawful Notice to ALL members of the Gardai. I sent it to numerous high ranking officers in the Gardai. I also included a link to this Lawful Notice to ALL members of the Irish Parliament.

The notice has had more than 260 views and there can be no doubt that every effort has been made to inform the Gardai that they are co-operating in the criminal victimization of men being prosecuted by the criminals in the Parliament and the LAW SOCIETY. The members of the Gardai **SHOULD** have refused to follow their orders because **THEY KNOW THE ORDERS ARE UNLAWFUL**.

Instead the Gardai have decided to put their pay packet ABOVE doing the job they are paid to do which is to maintain the peace and provide the protection of the law to the people living on the land of Ireland.

- iv. **Editors in Chief of News Outlets**

Reason: Suppressing news of all the above. Editors in Chief have the final say over articles and suppression of all this news makes the Editors in Chief willing accomplices to the war on fathers.

-
8. **@Members of the houses of Oireachtas.** You are hereby lawfully noticed:
- a. That given that a **STATE OF WAR** exists between all these groups and **FATHERS** on the land of Ireland I hereby claim and issue Lawful Notice that it is the **RIGHT, DUTY AND OBLIGATION** of the **FATHERS AND MEN** of Ireland to, in return, declare a **STATE OF WAR** against **ALL** these groups.
 - b. That given that ALL these groups have seen fit to attack and injure the wives and children of the men of Ireland I claim that acting on the “golden rule” of “do unto others as you would have them do unto you” that **ALL THESE GROUPS** are in agreement that **THEIR WIVES, HUSBANDS, AND CHILDREN** are legitimate targets for **ACTS OF WAR** by any father or man who lives on the land of Ireland who chooses to commit such acts of war.
 - c. That I wish to repeat myself to as to make sure that all members and all third parties who read this Lawful Notice are very clear on my claim. My claim is that
 - i. ALL members of the Parliament and their wives and children
 - ii. ALL members of the Law Society and their wives and children
 - iii. ALL members of the Gardai and their wives and children
 - iv. All editors in chief of news outlets and their wives and children

Are now claimed to be considered LEGITIMATE LAWFUL TARGETS FOR ACTS OF WAR BY ANY MAN WHO LIVES ON THE LAND OF IRELAND.

- d. That I claim it is the **right, duty and obligation** of the **fathers and men** of Ireland to make all efforts, including efforts of acts of war, to remove the criminal cartel of the members of this Parliament, members of the Law Society and Members of the Gardai such that freedom, peace and harmony can be restored to the land of Ireland.
- e. That I advise the men of Ireland that if they choose to do as Bono sang about some 20 years ago about black south Africans and “take up arms against their oppressors” that those oppressors will seek to cause such men injury, harm or loss if they come to their attention. So it is best not to come to their attention.
- f. That I advise the Men of Ireland that in prosecuting such a war men do not discuss their actions with anyone, preferring to remain totally, utterly and completely secretive of ones efforts. To “blend in and look normal”. That I advise men act unilaterally and on their own initiative so as to escape detection by the criminals in the Gardai.
- g. That I advise the Men of Ireland that the ONLY sort of “act of war” that will lead to success is one where there are no witnesses left to identify who the soldier was that committed the “act of war”.
- h. That I advise men that in the face of overwhelming evidence and all attempts to make peaceful remedy with these criminals in these groups some men have shown other men how to gain the attention of politicians. These men are such as Marc Lepine, George Sordini, Anders Breivik, and now James Holmes. Not even Thomas Ball, who burned himself to death, gained the attention of Politicians. Well? There is not one single politician in the western world who has not got the message of Anders Breivik.

“Deal with our grievances peacefully or we will kill your children”

9. **@Members of the houses of Oireachtas.** You are hereby lawfully noticed:

- a. That regardless of any persons individual opinion of Anders Breivik (and others) he has made the message very clear. That the most vulnerable and easiest targets for prosecuting the war that has been brought on men by the criminals in parliaments are the children of those members of parliament.

Anders Breivik has made it clear that members of Parliament will refuse to listen to men until they take DRASTIC action that some might find distasteful. That the editors in chief of news outlets in Ireland suppressed the closing statement of Anders Breivik is a clear indication that the politicians control the media and did not want the very well argued case of Anders Breivik to be in the public in Ireland.

Now. It must be remembered that "Allied Forces" dropped incendiary bombs on civilian populations in Germany during World War II in acts of mass murder with no military basis making it clear that the "Allied Forces" were quite happy to commit mass murder of innocent men, women and children as an act of war.

It must also be remembered that the "Allied Forces" dropped two nuclear weapons on Nagasaki and Hiroshima that were totally uncalled for thereby again making it very clear that the "Allied Forces" were quite willing to commit mass murder of innocent men, women and children as an act of war.

- b. That these same "Allied Forces" who have been causing wars all over the world for the last 50 years are the same people that the members of the Irish Parliament are so keen to do business with and so keen to support in their open and hostile war on fathers.
- c. That under the "do unto others as you would have them do unto you" golden rule the members of both houses of the Irish Parliament and ALL other groups named can have no complaint if an Irish "Anders Breivik" emerges to make his statement of resistance to the war on fathers in the most dramatic fashion possible.
- d. That the members of these groups can have NO COMPLAINT if individual Irish Fathers, who are totally fed up with the refusal of the members of the Parliament to deal with issues put before them so repetitively and so consistently, take the law into their own hands and commit acts of war against those who choose to oppress them.
- e. That the general population of Ireland can have NO COMPLAINT about any man who takes up arms against his oppressors as the general population of Ireland has spurned MANY CALLS for fathers to step forward and volunteer to sit on all men juries in all men courts and to provide fair and just court proceedings so that fathers can be offered the protection of the law.
- f. That I claim Ireland is now a lawless land because the general population of Ireland, as re-presented through the TNS community, openly choose not to establish "The Peoples Courts of Ireland" in the face of clear evidence of the criminality of the guvment.

-
10. **@Members of the houses of Oireachtas.** You are hereby lawfully noticed:
- a. That the date at the time of writing is August 21st 2012.
 - b. That I claim as of the date of September 1st 2012 until such time as “The Peoples Court of Ireland” is established that a **STATE OF WAR IS DECLARED AND EXISTS** and will exist between fathers and men of Ireland and those in the Parliament, Law Society, Gardaí and editors in chief of news outlets.
 - c. That the members of these four groups have until September 1st 2012 to give grave and deep consideration as to whether they wish the fathers of Ireland to return their declaration of war and do it in such a way that those men who declare themselves soldiers will go about their soldiering business in total and complete secrecy selecting their own targets of opportunity and committing their acts of war to their own best judgment as to their effectiveness.
 - d. That no trial and no due process of law is required to commit an act of war against a member of a group that is in a state of war with another group. In a state of war it is enough to be a member of a group to be LAWFULLY subject to an act of war. Since fathers in Ireland are already suffering acts of war there is no change there.
 - e. That all members of these four groups are being Lawfully Noticed via this Lawful Notice. I would ask those who read this to pass it along.
 - f. That any member of these four groups who wishes to resign from the group and denounce the criminal policies of the group may do so by September 1st 2012 and their resignation and denouncement will be posted to CAF Ireland to provide them some level of protection from acts of war, but by no means any guarantees.
 - g. That any member of these four groups that resigns from the group and denounces the criminal acts of these groups will, him or herself, stand trial once hostilities have ceased. There will be no amnesties.
 - h. That a public declaration by Enda Kenny prior to September 1st 2012 that this war has been prosecuted on fathers and that Enda Kenny, as the leader of the criminal cartel called “govement”, publicly declares hostilities have ceased from the guvment and that “The Peoples Court of Ireland” will serve as the appropriate court in which to prosecute those who have committed criminal acts. This needs to be said openly and publicly by Enda prior to September 1st 2012 to strike down my claimed declaration of a state of war. The “ball” is in Enda Kennys court. What he does with it is up to him.
 - i. That it is my strong recommendation that Enda Kenny make this announcement to end the War on Fathers in Ireland as a show of good faith and in the first steps in the path to peace between fathers and the criminals in the “govement”.
 - j. That should Enda Kenny refuse to make such an announcement and thereby maintain the guvments position in a state of war with fathers that any man who declares himself a soldier and commits an act of war against any member of these four groups or any woman who has criminally victimized a man shall be treated as a “prisoner of war” should he be caught and he will be treated humanely and released as a prisoner of war when hostilities cease no matter **WHAT ACT OF WAR** he committed. No soldier in this war will be subject to lengthy incarceration.

11. **@Members of the houses of Oireachtas.** You are hereby lawfully noticed:

- a. That this Lawful Notice and declaration of a state of war has been carefully crafted to put the onus of action back on to you such that each of you, as individual people, have the opportunity to make your own decisions in this matter. You each have a way of stopping the escalation of this war should you so choose.

You will decide to continue to be a willing participant in clearly criminal actions or you will decide to resign and denounce the criminal actions of your colleagues.

- b. That this Lawful Notice has been crafted to put individual accountability and responsibility onto the head of each member of these two houses. "I was only following orders" will not be considered lawful excuse and it will not protect you from angry fathers.
- c. That this Lawful Notice has been crafted in such a way that it does not require the agreement or consent of any group to prosecute the war on fathers in return. Each individual man can make his own choice for himself based on his own conscience and does not need to refer to any external "group".
- d. That this Lawful Notice has been crafted in such a way that each individual man in Ireland who reads this notice is faced with a decision only he can make.

That the decision he is faced with is:

"Will I take up arms against my oppressor and go to war with my guvment, the law society, the guardai and editors in chief?"

Naturally such a man is also faced with the question:

"What is the future of Ireland for our children if I am not willing to take up arms against my and their oppressor?"

And the answer to that is:

"Ireland will be part of a hard police state and the children of Ireland that survive will live in abject poverty and abject slavery".

Each man who lives on the land of Ireland who reads this Lawful Notice is faced with the same questions. No man who reads this Lawful Notice can any longer delude himself that "talking to the politicians" or "going through a political process" can have any hope of success. I have done that for nearly **FIVE YEARS**. There can be no doubt that the criminals in guvment do NOT wish to re-introduce the rule of law.

Each man who reads this Lawful Notice can clearly see that the criminals in the Parliament are not even following the EU Directives they HAVE to follow let alone are willing to support "The Peoples Court of Ireland" so as to re-introduce the rule of law into Ireland.

- e. That, fundamentally, should Enda Kenny continue to remain silent a state of civil war will exist in Ireland from September 1st 2012 but not the one planned for. The civil war will have very distinct targets for acts of war. Members of Parliament, members of the law society, members of the guardai and editors in chief of all news outlets.

-
12. **@Members of the Law Society, Gardai, Editors in Chief** You are hereby lawfully noticed:
- a. That the criminal calling himself Piarais Neary of Paul W. Tracey Solicitors in Ireland committed the crime of contract fraud when he assured me that the Irish Courts had jurisdiction to determine the matter of my divorce when they did not. The fact of the matter was that such claim was made by fraud and therefore the claim was null and void ab initio. There is no reasonable doubt that Piarais Neary was aware of the fraud.
 - b. That I have privately offered the criminal Piarais Neary the opportunity to remedy this criminal act for merely the cost of fees plus a reasonable interest payment making a total of EUR25,000 for him to refund to me, an amount he can easily afford. This offer expired on January 1st 2012.
 - c. That as a member of the Law Society Piarais knew that he was committing criminal acts and that his later refusal to make amends for what he knew to be criminal acts showed him up to be not genuine in his portrayal of “working in the best interests of his client”.
 - d. That my current price for Remedy from Piarais Neary is now EUR50,000.
 - e. That after September 1st 2012 Piarais Neary, should he not make remedy and leave the practice of family law, becomes a clear target of opportunity for any man who wishes to commit an act of war against him. I wonder if Piarais thinks that continuing to be a criminal and continue to lie to men and commit crimes against them might be a good idea now that he has been so publicly outed as a man who is a liar, criminal and thief while hiding behind that boyish charming outlook of being genuinely concerned.

I doubt that outlook is going to do him much good now he has been so publicly denounced. Committing contract fraud as a family law lawyer was a bad idea. Even worse for Piarais that he managed to get me assigned to him as a client. His unlucky day I guess. We all have them.

- f. That the **IRISH LAW SOCIETY** is, in fact, controlled by the **BRITISH LAW SOCIETY** and that those who are members of the **IRISH LAW SOCIETY** are, indeed, doing the bidding of the **BRITISH MONARCHY**.

How can you men and women do the bidding of the British after so many hundreds of years of out and out oppression by the British? Have you no shame? I guess not!

- g. That the **LEGISLATION** that the **LAW SOCIETY** falsely calls “LAW” is nothing more than the Uniform Commercial Code which was an invention of the European Aristocracy to control and regulate trade between the lands the Monarchs controlled. You members of the **LAW SOCIETY** are forcing upon **THE CREATIONS OF GOD...PEOPLE**...the legislation created for use in trading goods. This is an abomination. You should be ashamed of yourselves.
- h. That the Gardai threaten and abuse men, up to and including incarcerating them with threat of deadly force, based on all these LIES is a total and utter disgrace to **ALL MEMBERS OF THE GUARDAI**. Many of the men who commit these criminal acts have themselves been victims of the criminals in the family courts. Why then do you HELP those who criminally victimized you to victimize more people!?!?! Is your paycheck worth more to you than your honour? Your integrity? Sad for you if so.

-
13. **@Members of the Law Society, Gardai, Editors in Chief** You are hereby lawfully noticed:
- a. That all during this **FIVE YEAR** process the Editors in Chief of all major news outlets in Ireland have done the bidding of the criminals in the government and the United Nations by absolute suppression of the facts of the matter and refusal to perform anything even resembling balanced reporting of the issues at hand.
 - b. That the news industry is **SO CORRUPT** that when I spoke with Paul Le Large who is the Registrar for the Australian Federal Magistrates Court in Paramatta Sydney that he even suggested I take my story to the newspapers knowing full well that the newspapers are **TOTALLY** controlled by the government.

Our friend Rupert Murdoch is in enough hot water at the moment as the collusion between his newspapers and the government in the UK comes out into the open. No intelligent man can imagine that this cosy relationship between the **HIDDEN** government and the press does not exist in Ireland.

- c. That the Gardai were issued a Lawful Notice on March 22nd 2011, more than one year ago, in a very public plea for them to honour their oaths and work with me to re-introduce the rule of law into Ireland. This plea, call to justice, was turned down **TO A MAN** in the Gardai. That makes the men of the Gardai a total disgrace. They do not deserve their pensions. I will do my best to see they do not get them.

How **DARE** every single Gardai turn down the call to re-introduce the rule of law into Ireland in favour of his paycheck for being willing to enforce corporate policies emanating out of the United Nations!!

- d. That those of you in the LAW SOCIETY, Gardai and Editors in Chief would be very well informed to resign your positions and begin to denounce the criminal acts of your colleagues prior to September 1st 2012. Such resignation and denouncement will be published to the CAF Ireland site to afford you some semblance of protection from a man who chooses to declare his own war on you.
- e. That should you consider creating a public, open and transparent declaration of returning the war that has been brought to fathers in Ireland is not to your liking or agreement? You are entitled to your opinion. Just send me details of your track record and your efforts to re-introduce the rule of law into Ireland.

If you can not match my efforts by proven track record your opinion will be dismissed out of hand as not relevant. Only those who can point to a track record will get a voice at my table. Only those who can point to a track record will get a chance to attempt to persuade me that they have a better idea. The rest can try and convince **OTHER** men they have a better idea. I am done with all those who have done nothing telling me what I should or should not do.

14. **@ALL including third parties who read this** You are hereby lawfully noticed:

- a. That I and others have searched all over Ireland for fathers willing to create “The Peoples Courts of Ireland” and we have come up empty. Men in Ireland do not wish a path to justice for men in any significant number. This includes making the call for fathers on Jim Corrs facebook, calling for fathers on Fathers Rights web sites and facebooks, calling for fathers on the TNS web site which now has more than 3,000 members. Fathers in Ireland simply do not want a path to justice enough to even sit on a jury and be paid one ounce of silver per hour for such service. They would rather be slaves and complain about their slavery.
- b. That to demonstrate the poor performance of Irish Fathers in being willing to sign up to sit on new juries in new courts we now have in excess of 150 men signed up to Crimes Against Fathers in Australia. This compares to just FIVE in Ireland over the same period.
- c. That the evidence presented by the lack of response by Irish fathers is not refutable. The irrefutable fact is that Irish Men are not willing to stand up to the criminals in guvment in a public forum being a court of law. Given this fact then those Irish men who are willing to stand up to the criminals in the guvment in such a manner as not to identify themselves is the only other alternative to deal with these criminals.

As I started out with “Those who make peaceful revolution impossible make violent revolution inevitable”. In the case of the Irish guvment, it is the Irish guvment that has made a peace path to justice impossible for a period of nearly FIVE YEARS in my case and even longer for many other men. Those men who are fed up will be able to LAWFULLY deal with the criminals that they are fed up with as of September 1st 2012.

- d. That if anyone else who has worked as hard and as long as me who can show me their track record thinks they have a better idea? peter@peterolan.com will see you through to me.

I, and other Irish men have determined that there are no other groups in Ireland who have any better ideas. As Bono sang when pushed hard enough and there is no other path to justice men will “take up arms against their oppressors”. The trick is to notice who are the correct people to target as the “oppressors”. It is not the low level man in the street. It is those who are passing and supporting the criminal legislation and those who pretend it is law, those who enforce it, and those who refuse to inform the people of Ireland this is going on.

- e. That this Lawful Notice contains a large number of CLAIMS based on the evidence presented in the linked book The Truth Be Told.
- f. That the process of CLAIMS is to present the CLAIM and allow those who are informed of the claim a reasonable amount of time to respond to the CLAIM with a counter-CLAIM. Should any of those who are receiving this Lawful Notice wish to counter claim they can do so by sending a signed Lawful Notice or Affidavit to the fax number or email address mentioned in the header of this Lawful Notice.

-
15. **@ALL including third parties who read this** You are hereby lawfully noticed:
- a. That it is my hope, though I will admit a very low percentage expectation of this happening, that the widespread distribution and discussion of this CLAIM that the men of Ireland will have **JUST CAUSE** to declare **WAR** on their oppressors and take up arms against their oppressors might cause enough “shock and horror” that few more people might actually look into what is happening to find out why a man of such obvious intelligence and eloquence as myself would see fit to put forward a CLAIM of **LAWFUL DECLARATION OF WAR** against the members of parliament, the LAW SOCIETY, the Gardai, and the editors in chief of news outlets.
 - b. That those who would like to tell lies and make the claim that declaring this **WAR ON FATHERS** in **RETURN** to be in existence from 1st September 2012 is some form of “act of domestic terrorism” I have this to say. The real terrorists are the politicians, legal fraternity and police. They put ARMED MEN on the streets of Ireland who are so badly educated they do not know the difference between legislation and law. Indeed they are told legislation IS LAW and they are told they can enforce legislation on people who have **NOT CONSENTED**.

These terrorists are easy to identify. They call themselves Gardai and they strike fear into the hearts of innocent people. That the men of Ireland are so fearful of the Gardai that 99.9% of them are too fearful to sit on a jury publicly demonstrates that the **REAL TERRORISTS** are the **politicians, legal fraternity and the much hated Gardai**. That they call their brand of terrorism “rule of law” is nothing but a “big lie”, the kind that Joseph Goebbels said was more likely to be believed than a small lie.

- c. That it is my hope that Enda Kenny and those who advise him will review the mountain of evidence presented to him and the members of the parliament and take careful consideration of their actions towards Irish fathers. It is clear from my case and the case of tens of thousands of other fathers that, to date, men like Enda Kenny and Alan Shatter are more than happy to allow fathers to be criminally victimized.

Should men like Enda Kenny and Alan Shatter openly and publicly continue to support the criminal victimization of men and Enda Kenny NOT announce an end to the war on fathers? Then whatever happens next is what happens next.

As a man who has one daughter and two sons? It will be Enda Kennys decision alone that will bring his children into conflict with angry fathers. As a former father myself? I would never willingly bring my children into such danger. All it would take is one angry father. And fathers truly are the most dangerous men on earth. We shall see what sort of man Enda Kenny is this week. We shall see if he is willing to stop this war on fathers.
