Since you men have delegated your responsibility to punish crime to your 'legal fraternity' and your 'legal fraternity' will not do so then you would be well advised to take back that delegated authority to deal with criminals in your midst. My proposed version of dealing with criminals in your midst is to use the time honoured jury trial of 12 honest men of honour and integrity.

And should you NOT deal with criminals in your midst? Well? Don't complain to me when crimes are committed against YOU and no-one helps YOU. You men have an obligation to deal with criminals in your midst or you invite more crime against YOU and YOUR loved ones. It's that simple.

This web site disseminates scanned original documents, with Jennifer's signature clearly visible, which were represented to me as being signed by Jennifer and Jennifer has never contradicted this.

You will also find on my own site a series of affidavits accusing Jennifer of crimes against me.

These crimes are:

1. Perjury
2. Kidnapping
3. Extortion
4. Theft

You will find the evidence of these crimes on the site. You will find that Jennifer has at no time denied these crimes. You will also find the default judgment that finds her guilty of these crimes and the notice that I will be putting her on trial in Ireland as and when I can arrange a jury to do so.

Should you wish to confirm these crimes were committed you can contact Bill Toal on the details above. I doubt that Bill is going to be foolish enough to try and deny these crimes.

Further. As a result of committing these crimes I was caused serious injury, harm and loss. The kidnapping and abuse of my former children estranged them from me. One result was that I chose to dis-own these former ALLEGED children and I was suicidal in that process. I say ALLEGED as Jennifer refused paternity testing despite my former children being 14 and 16 at the time and perfectly able to be paternity tested and understand the results of that paternity testing.

Further, by attacking me with perjurous and false allegations and stealing money from my company I incurred in excess of EUR60,000 in 'legal fees'. My company was also destroyed. Lastly, due to her lies and criminal activity of the man calling himself magistrate David Dunkley, 95% of the proceeds of my 25 years of labour were transferred to Jennifer. You men want to know that 5% is the new 50% if you are a man and Bill and Irene Toal agree with this position.

Bill Toal was kept informed of his daughters crimes during the duration of this process which took just under three years to complete. Initially Bill Toal and my former step son, Jarrod Robinson, presented themselves as supportive of me because both men knew Jennifer to be lying and to be creating conflict to line her own pockets with money she did not deserve.

Bill Toal and Jarrod Robinson reported to me that they were shocked at the false allegations, perjury, committed by Jennifer and both reported to me that they told her to stop. Apparently Jennifer told them to 'butt out'. I told both men to not involve themselves in this dispute so as not to bring themselves into conflict with me.

Alas, Bill Toal chose to loan money to the alleged (by Jennifer on affidavit) amount of \$A35,000. Further, Jarrod Robinson made available his bank account to transfer money into in Ireland. Jarrod Robinson has made no denial of this allegation. It's likely not useful for him to deny it since I have the email on which he sent his account details to his mother. I presume that Kristen Robinson loaned money to her mother to also fund her legal attack on me. I say this as I have the email exchange between the three and the logical reason Kristen Robinson is on that email trail is that she had a job and would have money to loan.

By loaning money to Jennifer while they were fully aware Jennifer was committing the crimes of Perjury, Kidnapping, Theft and Extortion Bill Toal, Irene Toal, Jarrod Robinson and Kristen Robinson all committed the crime of 'accessory during and after the fact' for each crime.

It has been established for hundreds, if not thousands, of years that to willingly and knowingly assist a criminal in their criminal activities brings the same penalty on any accomplices as an 'accessory' to the crime. Therefore, Bill Toal, Irene Toal, Jarrod Robinson and Kristen Robinson are all just as guilty of the crimes of perjury, kidnapping, extortion and theft as is Jennifer.

This is a very well establish precedent. It is up to a jury to decide what to do with it.

ALL these people could have stayed out of this mess by insisting that Jennifer use the money that was the proceeds of our house to fight her own battles and refuse her support or assistance so long as she was committing crimes. Each of these five people are adults. Each are responsible for their own actions. Therefore each are guilty of serious crimes.

Should the men of Wagga refuse me a path to justice for these crimes committed against me? Don't be complaining to me when the police don't come to help you when someone commits a crime against YOU. Don't come complaining to me when YOUR son has his children kidnapped and his life's work destroyed by a criminal wife wielding the criminal 'just-us' system.

Don't come complaining to me when YOUR son commits suicide.

Don't come complaining to me when your bother, your father, your uncle, commits suicide from the abuse of the Family Courts. You men likely don't know 4,000 men a year are estimate to commit suicide from the abuse of criminal wives and the criminal family court and the criminal CSA.

Don't come complaining to me when men start KILLING their WIVES and their children in rapidly increasing numbers because these men know they will be destroyed by the criminal legal system and they start lashing out in anger because they know no-one will help them when they have crimes committed against them.

Don't come complaining to me when men start taking the law into their OWN hands and refuse the 'rule of law'. I have been able to point out clearly that the rule of law does not exist in Australia.

Are you men getting my message? If you do not pull your fingers out of your arse and protect the rights of men like me, and there are hundreds of thousands of us in Australia, don't come complaining to me when YOUR lack of backbone and action comes home to roost to YOU.

And it is already roosting. The fluoride in your water, the aspartame in your food, the aluminium being dumped on you in chem tails, added to your deodorant, added to your cook ware, the mercury in your vaccines and chemicals in your plastic bottles is poisoning YOUR children.

There is no man in Wagga or surrounding area who does not have loved ones who have been poisoned by your guvment. ALL of your relatives living in Australia are being poisoned by your guvment. And if you do nothing about it? They will have their lives shortened because of this poisoning.

I am working on the remedy for these crimes being committed by your guvment and legal profession by establishing common law courts in Australia with my precedent setting case against the criminal magistrate David Dunkley. Kevin Rudd, Julia Gillard and many others are VERY unhappy with me. GOOD!

And Gentlemen? Let me tell you this. I have spent a total of about 3,000 hours at a personal cost of about \$A500,000 to get this far. I have close friends in Germany who tell me you men are not worth my trouble. They say that you are too spineless to do anything about this. So far? They would be right. Are they going to remain correct? Well? That is up to you men, isn't it?

And Gentlemen? I will point out to you that young men are watching the men of my generation. The 45 or so year olds like me. They know the guys who are 55+ are a bit 'past it'. But they look at the guys in our age band, the 40-55 year olds and they wonder what we are up to.

Let me share with you. Here is what a 22 year old man sent to me in an email.

*Just want to take a moment to say thank you for all your dedication to this cause and to saving men's lives. Based on your actions I can tell you actually **have a heart** and are genuinely looking out for the well-being of young men such as myself. In particular I have found your information regarding women to be **VERY** enlightening, this same **crucial** and **vital** information about women for young men is so ruthlessly suppressed by the media.*

*I can now clearly see who my friends are and who they are not. To give you an example, a few weeks back my aunt (mid-50's) came to visit me. While she was here she kept going on and on about "You're so tall my baby, we need to get you married" and "When you get out of school the girls are gonna love you, we need to find you a good girl who knows how to cook".*

*Now, had I still been in the dark about women I would've thought what she said was a good idea and mostly benign, but now that I know the truth, I can **CLEARLY** see she does not have my best interests in mind, she is merely trying to get "babies" in the form of grandchildren so **SHE** can talk and brag about with her female friends.*

*In another incident recently at work, an new woman (mid-30's) who just started was chatting up people during lunch and she asked me "You're pretty tall, are you married? You need a girlfriend".*

*You were 100% right!!! They're **ALL** in on the marriage scam!!! It's **CRAZY** to see this stuff proven to be true in real life scenarios!*

*Keep doing what you're doing man, **DONT EVER STOP***

My heart is warmed that I am instrumental in saving the lives of young men. Men the age of YOUR sons by the way. I am certainly doing more for them than other men my age.

Do you gentlemen of my vintage know what such young men think of you? They think you are nothing but a bunch of "mangina whimps". THAT is what they think of you. That you ALLOW women to commit crimes against you with impunity? That you allow them to steal your children, your money, your house and in some cases your very lives through suicide?

THEY think YOU are a MANGINA WHIMP and they are not afraid to say so.

They think you are pathetic the way you keep your balls in your wife's purse and only ask for them if you really need them. Quite frankly? They are disgusted in you and have no desire to be like you, associate with men like you, or do anything like you. By your abdication of the rule of law? You have lost your 'moral authority'. They don't believe you know right from wrong. They don't believe you would do anything about it even if you did. They believe these things because the evidence is in front of them that you will not do anything when faced with crimes. You have lost their respect.

And, of course, they are opting out of marriage and 'relationships' in their tens of millions.

I've spoken to HUNDREDS of such men who have asked me words to the effect:

"When did all your mates become such whimps?"

They are contemptuous of men JUST LIKE YOU who will roll over and play dead when women steal from them, who will roll over and play dead just because the cops rough you up a bit. And sad to say I was ONE of you 'magina whimps' before I realized that an estimated 4,000 men in Australia kill themselves each year. Yep. I was a clueless spineless whimp as well. I had no idea how bad it was.

This is why I am addressing this letter to the MEN OF WAGGA WAGGA who are of my vintage in the main. Because I am here to give you the 'wake up call' that young men are disgusted in you. What you do with that wake up call is up to you.

So if you do not want to be the object of disgust and loathing of the younger generation of men? If you want their respect? You are going to have to earn it. Because you men sure have lost their respect for good reason. You men might want to think about growing some backbone around my specific case as well as the MANY other cases that will have occurred in Wagga.

Gentlemen? I can assure you. The backlash against women is coming via the younger men. If you have daughters? You are as responsible for the backlash they are going to be subject to as any woman. You men could have listened a little harder to men like me ringing the bell about the crimes of the family courts.

There is no way to stop the backlash that is coming, it will only be mitigated. A part of mitigating that is the book that was written through me. You can find the draft here:

I called it 'Living Free in a Fem-Nazi World'. One of the reasons I live in Germany is that the men there know what a Nazi Totalitarian State looks like and they don't want another one. It seems you men do NOT know what the early signs of these are.

Well? Look around. YOU ARE LIVING IN ONE!

Each man of my vintage? If you do nothing now? You are selling your children into abject slavery. Take a look around. You know things are 'seriously wrong' but you can't put your finger on it in many cases. Well? Your guvment is a bunch of criminals as are your police and legal and banking fraternity. THAT is what is 'wrong'.

I have extracted myself from that system. I live free in this Fem-Nazi world. But not 1 in 1000 men in Australia have the same chance as me to escape. You are going to restore the rule of law in Australia or you are going to live in abject slavery. Me? I'm 'out'. And I am never coming back to live.

You men want to take a good close look in the mirror. You know what you are looking at? You are looking at the new 'black-jew'. Because not even the blacks in slave time USA or the Jews in Nazi Germany pre-hostilities could have their sons taken from them by the state. That's because those men would fight back for their children with real vigor. Now? Men don't even do that they are so bamboozled by the 'guvment'. They just go to the 'criminal courts' and get robbed blind. Then? Any man that 'complains' about being robbed blind is then further criticized and slandered. You men ought to be ashamed that the estimated number of men killing themselves each year from this abuse is about 4,000. What have YOU done to assist them?

So. Now you men know that Jennifer Toal, Bill Toal, Irene Toal, Jarrod Robinson and Kristen Robinson have accepted that they are criminals? Those of you who know the men involved with Susan Toal, Crissy Toal, and Kerry Toal? Don't you think you owe these men a word of a warning? Let them know the kind of people they are dealing with? If those men decide to stay? So be it. But they are entitled to know that the entire Toal Family is quite happy to commit crimes against the husband of one of their daughters to gain the maximum amount of money out of that man. 95%.

Isn't 'look after your mates' what we all learned on the football field?

When did you, my peers, forget to "look after their mates against all who would do them harm?"

When did you, my peers, start to condone child abuse just because it is the mother doing it?

You wouldn't let one of your mates abuse a child, why do you let one of your mates wives abuse children?

I don't know the men involved with Susan, Crissy and Kerry Toal since I have been out of the country for 10 years now and so have not met the 'latest crop'. After all. None of them have been able to keep a man for a long time. You can talk to Murray Reid or Jock Buckins about that. More discarded 'first husbands' of the Toal girls. With three of four daughters divorced (Jennifer twice now) and a son, Michael who is mentally unstable (I will present the evidence for that later) Bill and Irene have not done such a good job of 'contributing to the community' into which they moved in 1976. Have they?

So, I would suggest, if the men here want to do what I would call your duty?

You will pass the evidence I present to the men involved with any of these girls.

You will contact the employer of Michael Toal and present the evidence in the appendix below.

You will call Bill Toal and ask him for an explanation of what he is going to do to remedy the crimes committed by his family against me.

If Bill is not willing to offer the remedy I proposed then I would ask men here to also form a common law jury for the crimes of the Toal family. Crimes committed while living in YOUR community. And if you do not remedy these crimes? Don't complain to me when you have crimes committed against YOU and YOURS. I am not coming back to Australia. It's full of spineless whimps and out of control criminal women now. VERY different to Germany.

What Remedy did I propose? Right at the start in November 2007 I proposed a split about 66/33 in Jennifers favour. I proposed:

1. 50/50 split from the proceeds of the house. (Which she had actually promised she would not ask for based on a previous agreement that her son Jarrod Robinson can confirm.)
2. Maximum child support awardable in Australia.
3. Furniture to go to her as I did not want to come back to Australia.
4. Smile and say 'irreconcilable differences' and keep to myself how disgracefully Jennifer had behaved in our marriage. She behaved so disgracefully Jarrod Robinson has said to my face "I would never get married because I might get a wife like my mother." That is as damning an indictment of a wife and mother as one man can give. Her own son. At 26.

When I spoke with Bill Toal in November 2007 about this package to get rid of his troublesome daughter? He told me that it was a “generous offer, more than Jennifer deserved, more money than I have myself.” That is from the woman’s FATHER.

Yet this man still chose to commit crimes against me? Well? He has to be punished for allowing these crimes to happen in his family. If not? More men like Bill Toal will allow their daughters to do the same. That’s how it works. Indeed, for every woman who has behaved disgracefully in divorce? There is a father who did NOT pull her into line and make her obey the law.

Once Jennifer started hostilities my proposed offer changed to:

Bill Toal and my father, John Nolan, to sit down over coffee and to settle matters between them. I agreed to Bill and my father that I would agree to any deal they BOTH agreed was fair and equitable.

I told Bill to talk to his daughter and tell her “this is how it is going to be” because if she continued hostilities all that would happen would be that money so hard won would be spent on lawyers and animosity would be created. He left out “crimes would be committed”.

I do not know if this offer was put to Jennifer ever. I did email it to her as well.

Fast forward 2.5 years to mid 2010? Once I realized that 95% of proceeds of my 25 years of labour had been forwarded to Jennifer? I sent Bill Toal an email and told him that I expected the ENTIRE AMOUNT to be moved back into my bank account and that he had MY WORD that all debts would be property paid and then HE and my father would work out what to do with the rest.

I told Bill Toal that since he had chosen to be an accomplice to crimes against me that this was my final offer for remedy in the relative private and if he was not willing to provide remedy for his crimes and the crimes of his family in private that I would make those crimes public.

I strongly recommended he did not take the path that would require me to make the crimes of his family public to gain remedy because that would disgrace his family for some time to come.

Alas. Bill Toal has remained silent on this matter.

Hence this letter.

Gentlemen? What you do now is up to you.

## **Appendix – The Crimes of Michael Toal**

Gentlemen. I have created an appendix for the crimes of Michael Toal. I did this to get them out of the main body of the letter.

Michael Toal made no contact with me during this whole process. Many of you would remember that Michael and I were friends at school and it was my time as a boy in the Toal household that had me meet Jennifer in the first place.

During the process of bringing the rule of Law into Australia I spoke to many people. One Michelle McDougal, who was in my class at school, put a 'friend' request into my face book. I accepted this friend request and we chatted briefly about how our lives had turned out to date.

Michelle is involved in the church and so I talked about how 4,000 men a year kill themselves from the abuse of the guvment, how the church is nothing but a 'front' for Satanism and how it is high time women started speaking out about the crimes their sisters are committing against men with impunity.

I noted how there was already a trend of increased numbers of murders by men of their wives and children and noted how the men needed a path to justice if this was not to rapidly increase.

Michelle, to another friend, admitted that she passed my messages directly to Michael Toal. The reason I had reason to ask was that at that time I received a 'friend request' for one 'Tim Potter' who was also a 'friend' from two other people in my friend list. One of them being Michelle McDougal.

I accepted this 'friend' request and 'Tim Potter' proceeded to make false allegations I was a paedophile on my facebook page. This is slander and it is a crime. So I kicked 'Tim Potter' off. There was then a character calling himself 'legshagglor' who started posting my photograph and contact details on gay mens sites as well as escort sites and claiming I was a paedophile. Again. More slander.

Obviously no-one is going to take much notice of such rubbish but a crime is a crime and I was interested to find out who it was. Well? My evidence is that it turned out to be one Michael Toal. Michael has never denied that he was 'Tim Potter' or 'Legshagglor' or a range of other names that were used to slander me and use my photograph in violation of my copyright of my image.

You men here might like to know that Michael is in the habit of making false allegations against me for being a paedophile across numerous web sites. You men here might like to call his employer and tell them that. I am pretty sure no man in Australia wants to work with ANY man who has sunk so low as to make false allegations of paedophilia in the current climate of 'hysteria' whipped up by your women.

But that was not enough for young Michael. He then went to MANY forums in which I was using a persona to break the news of the criminality of the legal system, the subversion of women through feminism, and the crimes women were committed via men. I was working on 'establishing credibility' for my efforts at this time while remaining just a little anonymous. After all. To not be anonymous would also reveal Jennifers name and the name of my former children. We are linked and there is nothing I can do to erase those links.

Michael came to many of these forums and posted my photograph, a copyright violation, and made slanderous remarks about me, a series of crimes.

He further contacted the administrators of the 'Free Man Australia' web site and made threatening comments that quite disturbed these men. I explained to them that it seemed Michael Toal had become a little mentally and emotionally unstable following his period in Somalia and it seemed to have been exacerbated now. I told them not to worry about him as he was full of 'hot air' and unlikely to be a problem.

I contacted Bill Toal and informed him of the crimes his son was committing, congratulated him on turning out yet another criminal, and told him that if Michael chose to make threats towards my family I would have his fingers broken to negate the viable threat he was.

I had thought Michael had settled down after that. Subsequently I was sent an email from one of the Admins of the Free Man Australia web site.

Reply by globalman 6 hours ago

Psion,

"Maybe we will go back to more mundane issues like how the case against David Dunkley et al is progressing?"

David is toast. As is Louise Henderson. I will get a jury up and running. They have admitted guilt by non-response. I will get my remedy instructions.

THEN we will see how we go with outlawry and lawful assassination... ;-)

I'm pretty sure that as more and more men realise that people like Louise Henderson and David Dunkley are scumbag criminals and that they have been outlawed and no longer enjoy the protection of the law....that one of two of them might step up to the plate and dish out a little 'summary justice' in line with how criminal scumbags like this have dished out criminal justice.

In the end. All that needs to happen is for men to act in isolation led by their conscience.

A militia man is a 'a man with a gun and a conscience'.

Men in Australia need to arm themselves with high powered rifles with telescopic sights. And then make sure that criminal scumbags like David Dunkley know full well that such weapons are in the hands of right thinking men. THEN you will see scumbags like David Dunkley obey the law.
