Salutations. Firstly I wish to address a point of law, common law. I am in receipt of a letter mailed to the corporate fiction named "MR. PETER ANDREW NOLAN" incorporated on 11/1/1964 which you mailed on 22/100/2009. It has a reference number on it of PAC6601/2007. I can confirm that I have received this letter noting that you are proposing some sort of business meeting you have called a 'Final Hearing' at the place of business of a human being calling himself David Dunkley.

Since you have invited me to a meeting please find attached my Fee Schedule for attending any such meeting. The fee schedule for my presence at this meeting to which you have invited me is TEN TROY OUNCES of 99.99% PURE GOLD PER HOUR or portion thereof. Failure to rebut this fee schedule in a lawful affidavit prior to Wednesday 17th of November will result in a default judgment and acquiescence by default.

Since I will be required to travel from London to Sydney to attend the meeting to which you have invited me I shall add the amount of FIVE HUNDRED TROY OUNCES of 99.99% PURE GOLD as compensation for the travel time that will be required of me to attend the meeting to which you have invited me. The Bill for this travel time is attached and will be payable prior to any proceedings of the meeting beginning. As yet, no authorized re-representative of the private run for profit company calling itself "The Australian Federal Magistrates Court" has contacted me to describe the purpose or process of this proposed business meeting. I am sincerely of the belief that no effort to contact me has been made.

Further, no authorized re-representative of the private run for profit company calling itself “The Australian Federal Magistrates Court” has been willing to respond to my lawful notices and has in no way established any contract with or jurisdiction over any of my business dealings to the best of my knowledge. This means the human being calling herself Louise Henderson is in lawful dis-honour of my lawful notices.

It seems to me that the re-representatives of the private run for profit company calling itself “The Australian Federal Magistrates Court” are just as tardy in their prosecution of their business as are their partners in crime the ‘Lawyers’. It is interesting to see how quiet you people are when you are challenged. All that education? All those fancy titles? All that government money that you get? And yet you can not respond to the simplest of lawful notices? My, my. You are starting to show how thin the veneer of ‘justice’ is in the land known as Australia. These letters will make fascinating reading to the various men on the Men’s Rights sites around Australia when they are published.

Given that I am sincerely not aware that this meeting has been cancelled by the specified time frame, and that I presume the purpose of the meeting is for your corporation to attempt to further steal the proceeds of my labour and my rightful property, I have purchased travel to come to this meeting to defend my interests against your criminal cartel.

I am none best pleased at needing to come to Sydney to defend my interests against your criminal cartel. My expectation is to Bill approximately 660 Troy Ounces of 99.99% pure gold to the human being who turns up on the day. I shall insist on immediate payment for the 500 Troy Ounces of 99.99% pure gold prior to proceedings beginning.

Whichever human being turns up on the day will be required to bring this gold with him to pay my Fee Schedule. Further attempts to proceed with the meeting without payment will incur a further fee of ONE THOUSAND TROY OUNCES of 99.99% PURE GOLD for lawful dis-honour of a lawful Fee Schedule and presented Bill.
