1. Notices and Explanation

This lawful notice is issued under the maxims of law:

- *"All men (and women who claimed equality) are equal before the law"*
- *"Ignorance of the law is no excuse"*
- *"Let justice be done though the heavens may fall"*
- *"Notice to Agent is Notice to Principal"*
- *"Notice to Principal is Notice to Agent"*

Notice to any human being reading this if you are not the woman calling herself Julia Gillard.

This fax (save a tree) is a Lawful Notice issued under the common law jurisdiction of the land known as Australia. No other human being is authorized to deal with this communication.

Julia may choose to delegate this communication but that must be HER decision only after reading this lawful notice. This is a very serious and important lawful notice that must not be ignored.

2. Greetings and Summary

Dear human being calling herself Julia Gillard,

Salutations.

This Lawful Notice is of the utmost urgency and importance.

On 2011-03-24 I sent to your fax machine a Lawful Notice to all Policy Enforcement Officers of your COMMONWEALTH OF AUSTRALIA. I instructed you to ensure that all your Policy Enforcement Officers are informed of this Lawful Notice.

Today I am told a colleague commonly known as Ian Henke has been unlawfully kidnapped and incarcerated. He is an elderly and ill man. He poses no physical threat to anyone. He is harmless.

Look what they did to the Kennedys.

If I were you Julia? I would resign immediately to remove yourself from the position of committing more crimes against me and my fellow Australians.

3. Lawful Notices

3.1 Specific Issues Relating to alleged kidnapping of Ian Henke

You are hereby Lawfully Noticed of the following.

1. I have been informed of the following in writing by a very reliable source:

*Just heard Ian Henke has been jailed in Queensland last Friday
Ian lives in Melbourne & is not a well man. His pension has been cut & his wife is struggling as
it is without having the loss of this pension*

*Ian was the key man behind the Institute of Taxation Research - who organised the printing of the

book Australia - the Hidden Colony, as well as taking the ATO to the High Ct & later to Privy council in
UK*

For his efforts - he is a targeted man

2. We shall progress for the time being on the basis that this report is true.
The man providing this information has no reason to lie to me.

Should this report prove to be false I will most assuredly apologise for any inconvenience I
have caused.

3. You were faxed on the 24th March 2011 the Lawful Notice to All Peace Officers also acting as
Policy Enforcement Officers on the land known as Australia.

You were instructed to ensure that all your employees who are Policy Enforcement Officers
were to read this Lawful Notice.

4. This Lawful Notice stated that from April 1st ALL Policy Enforcement Officers would be
deemed by "The Peoples Court of Australia" to have been lawfully noticed of this Lawful
Notice.

5. Should it turn out to be the case that Ian Henke has been unlawfully kidnapped or incarcerated
on or past the date of April 1st 2011 you and the Policy Enforcement Officers involved in this
crime will be Accused and duly processed by "The Peoples Court of Australia".

4. Proposed Remedy

It is proposed.

It is proposed:
