And the Court grants liberty to the Applicant's solicitors to notify Google Ireland Ltd., Google Inc., Whois Privacy Protection Service Inc., and Host Collective Inc., by E mail of the making of the Orders herein together with Penal Endorsement contained therein.

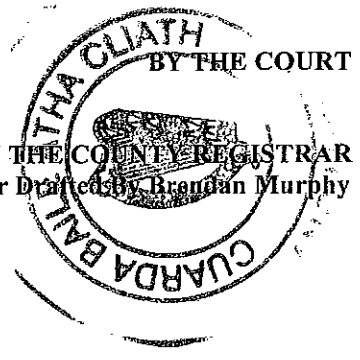
